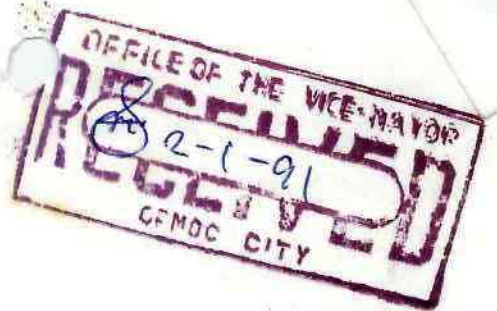

RESOLUTION NO. 06

A RESOLUTION CONCURRING THE MAYOR'S PERMIT GRANTED TO THE COCKPIT
