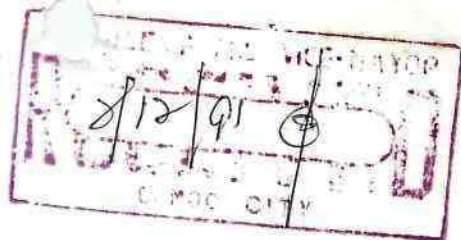

RESOLUTION NO. 08

A RESOLUTION URGING THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND THE LAND TRANSPORTATION FRANCHISING REGULATORY BOARD TO GRANT AUTONOMY TO EACH REGIONAL, PROVINCIAL, AND CHARTERED CITY (LOCAL) GOVERNMENTS IN THE DECISION MAKING FOR THEIR RESPECTIVE CONSTITUENTS ON PRICES AFFECTING RATES FOR PUBLIC UTILITY VEHICLES SPECIALLY DURING TIMES OF CRISIS.

WHEREAS, the decision making on passenger fares is always under the jurisdiction of the "Manila Government";

WHEREAS, this august Body believes that the local governments should be given a free-hand to decide what is reasonable and just passenger fares to be imposed on their respective localities because they know better in addressing the needs of their respective constituents than those people who have their seats of office in Metro Manila;

NOW THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., severally seconded by mga Kagawad Gregorio A. Yrastorza, Jr., Arnulfo C. Salazar, and Benjamin F. Tugonon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution URGING THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND THE LAND TRANSPORTATION FRANCHISING REGULATORY BOARD TO GRANT AUTONOMY TO EACH REGIONAL, PROVINCIAL, AND CHARTERED CITY (LOCAL) GOVERNMENTS IN THE DECISION MAKING FOR THEIR RESPECTIVE CONSTITUENTS ON PRICES AFFECTING RATES FOR PUBLIC UTILITY VEHICLES SPECIALLY DURING TIMES OF CRISIS;

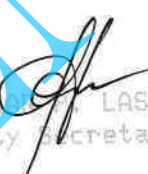
