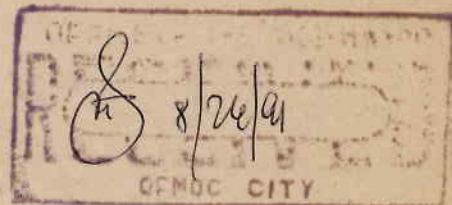

RESOLUTION NO. 101

A RESOLUTION AMENDING RESOLUTION NO. 160 S. 1990 BY PRESCRIBING NEW
FARE RATES FOR MOTORIZED TRICYCLES IN ORMOG CITY FOR THE PURPOSE OF
REDUCING THE APPROVED RATES AS PROVIDED IN THE AFORENUMBERED
RESOLUTION.

WHEREAS, due to current reduction of the prices of gasoline and
other fuels, the Committee on Transportations & Communication has
conducted a Public Hearing with the Tricycle Operators and Drivers on
August 22, 1991 at the Sangguniang Panlungsod Session Hall, this city,
on the feasibility of reducing the existing fare rates of motorized
tricycles operating in Ormoc City and in its immediate suburbs;

WHEREAS, in said public hearing, the operators and the drivers of
motorized tricycles were amenable to reasonable reduction of fare rates;

WHEREAS, through the representation by the Honorable Chairman,
Committee on Transportation & Communication, the Honorable MEMBERS of
the SANGGUNIANG PANLUNGSOD ng ORMOG, in SESSION, is made knowledgeable
of the agreed reduction of fare rates for motorized tricycles and, has
considered commendable said reduction of rates, hence necessitating due
response and immediate action;

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., duly
seconded by Kagawad Gregorio A. Yrastorza, Jr., be it

RESOLVED, to pass a resolution AMENDING RESOLUTION NO. 160 S. 1990
BY PRESCRIBING NEW FARE RATES FOR MOTORIZED TRICYCLES IN ORMOG CITY FOR
THE PURPOSE OF REDUCING THE APPROVED RATES AS PROVIDED IN THE
AFORENUMBERED RESOLUTION;

RESOLVED, FURTHER, that the following below be the prescribed Schedule of the New Fare Rates of Motorized Tricycles, (and, with emphases on compliance of a specific condition contained therein and on the penalties for violations thereof):

THE ABOVE RATES SHALL AT ALL TIME BE POSTED ON THE WINDSHIELD OF EACH AND EVERY MOTORIZED TRICYCLE FOR THE INFORMATION OF THE GENERAL PUBLIC.

DRIVERS VIOLATING THIS RESOLUTION ARE TO BE PENALIZED AS FOLLOWS:

1. First Offense - Suspension of operation for 10 days
2. Second Offense - Suspension of operation for 20 days
3. Third Offense - Suspension of Mayor's Permit

RESOLVED, FURTHERMORE, that the above Schedule of New Fare Rates shall be the current fare rates of motorized tricycles in Ormoc City; nevertheless, still subject to the final approval of same by the Land Transportation Franchising and Regulatory Board (LTFRB) in Tacloban City;


