

RESOLUTION NO. 104

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS THE CONDUIT OF SEVEN (7) REBEL RETURNEES OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG).

WHEREAS, it is the national policy of the government to extend to Rebel Returnees all necessary assistance to facilitate their return to the folds of the law and democracy, and, in this endeavor, all government agencies and offices should help or give support to, one way or another;

WHEREAS, the Department of Interior and Local Government (or DILG) is implementing the "Rebel Returnee Livelihood Assistance Program" and, is interested in allowing the participation of the City Government of Ormoc to act as CONDUIT of the Seven (7) Rebel returnees - Beneficiaries in Ormoc City, namely:

- 4) Probilina Danas
- 5) Lucena Arcepe
- 6) Demetrio Danas

WHEREAS, this program of our national government is indeed praiseworthy, hence be accorded with due course and immediate action;
