

## RESOLUTION NO. 105

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR MA. VICTORIA L. LOCSIN, CITY MAYOR OF ORMOC, TO SIGN AND ACCEPT, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS DONEE, DEEDS DONATION WITH THE LOT DONORS MR. AND MRS. MELCHOR AND RITA LARRAZABAL, MR. DIONISIO TORREVILLAS, BOTH LOTS DONATED ARE LOCATED AT BRGY. NUEVA VISTA, DRMOC CITY, AND WITH MS. MELECIA L. CABILING FOR A DONATED PARCEL OF LAND LOCATED AT BRGY SAN JOSE, ORMOC CITY.

WHEREAS, this august Body is in receipt of the Deeds of Donation executed by the fallowing donors:
