Apoderado, Veterinarian IV, Office of the Veterinary Services, Ormoc City, has requested this august Body for passage of a resolution requesting the International Welfare for Animals, through Dr. Lydia Calcinea Mangahas of 786 Aurora Buolevard, Quezon City, for availability of Rabies Vaccines for dogs;

WHEREAS, these rabies vaccines are intended for immunization of dogs which are composed of living but weakened rabies virus and injected intra muscularly to the dogs;

WHEREAS, once the dogs have already been vaccinated they become free from rabies thus minimize death incidents to those persons who are victims of dogs' bite;

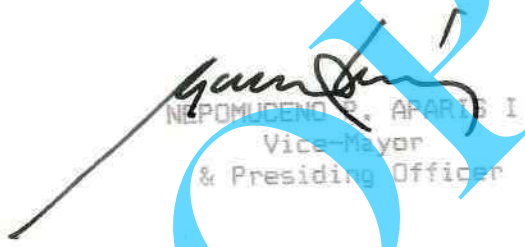
