A RESOLUTION CREATING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) IN ORMOC CITY.

WHEREAS, in pursuance to Section 43 of Republic Act No. 6975, otherwise known as the "Department of Interior and Local Government Act of 1990", the Honorable City Wayor has requested in writing the Honorable Sangguniang anlungsod for the creation of the People's Law Enforcement Board (or FLEB) for the City of Ormoc;
