## RESOLUTION NO. 115

A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE PORTS AUTHORITY (PPA) FOR A 50-METER LENGTHENING AND WIDENING OF THE ORMOC CITY PORT.

WHEREAS, Her Honor the City Mayor, has requested in writing the Honorable Sangguniang Fanlungsod to pass a resolution requesting the Philippine Ports Authority for a 50-meter lengthening and widening of the Ormoc City Port

WHEREAS, this august Body had then enacted Resolution No. 45 dated 13 June 1991 entitled, "A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE PORTS AUTHORITY (PPA) FOR THE CONSTRUCTION OF A 50-METER EXTENSION OF THE ORMOC CITY PIER. ";

WHEREAS, we had alleged in said resolution the following reasons of our request:

- a) That the existing Ormoc City pier, constructed in 1934, is fast becoming an absolete vintage - short and narrow - which can hardly accommodate the heavy filings and flow of cargoes to and from docked ships, barges and other boats, -a situation which greatly endanger the security and safety of the people, mostly passengers, who walk through hectic passage to and from anchored vessels;
- b) That Ormoc City of today has become the focal point of entry and departure of many sea travellers daily, hence it needs a more spacious city port;
- That the requested extension would surely accommodate more vessels and facilitate the services necessary to the riding public and their cargoes, besides, it would also generate more revenues to the government.

WHEREAS, up to now, no response by far from the PPA is communicated to the City Government of Ormoc relative to this sincere request for extension of the Ormoc City Port;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, duly seconded by Kagawad Eufrocino C. Codilla, Jr., be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE PHILIPPINE PORTS AUTHORITY (PPA) FOR A 50-METER LENGTHENING AND WIDENING OF THE ORMOC CITY PORT;

ENACTED, September 19, 1991.

RESOLVED, FURTHER, to furnish copies of this resolution each to the General Manager, Philippine Ports Authority (PPA), Port Area, Manila, with Speical Copies to Her Excellency, President Corazon C. Aquino, Malacañang, Manila, and the Honorable Secretary, Department of Transportation and Communications, Manila; Honorable Carmelo J. Locsin, Congressman, 4th District - Leyte; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; the PPA Tacloban Office, Tacloban City, and the Ormoc PPA Office, Ormoc City;
