

RESOLUTION NO. 117

A RESOLUTION OF CONCURRENCE TO THE CERTIFICATE OF NO OBJECTION GRANTED BY THE CITY MAYOR'S OFFICE RELATIVE TO THE REQUEST OF MR. LORENZO BALTONADO, REPRESENTING THE BACH CONCRETE AGGREGATES COMPANY, INC., TO UTILIZE A PORTION OF ITS RECENTLY ACQUIRED PRIVATE PROPERTY SITUATED AT PANILAHAN RIVER, BRGY. MACABUG, ORMOC CITY, FOR SAND AND GRAVEL OPERATION.

WHEREAS, the Bach Concrete Aggregates Company, Inc., through the representation of Mr. Lorenzo Baltonado, has requested in writing Her Honor, the City Mayor, for issuance of a Certification of NO OBJECTION to the portion of private land the Company has recently acquired for the purpose of Sand and Gravel Commercial Permit Application located at Panilahan River, Barangay Macabug, Ormoc City;

WHEREAS, the Honorable Acting Mayor Nepomuceno P. Aparis I, vice the City Mayor, the latter being Out-of-Town on Official Business, has endorsed the aforesaid request to the Honorable Sangguniang Panlungsod, requesting that august Body for concurrence, so stating that the City Mayor's Office has offered no objection to the Company's application for Sand and Gravel Commercial Permit utilizing thereby a portion of its recently acquired private land situated at Panilahan River, Barangay Macabug, this city, for the purpose;


