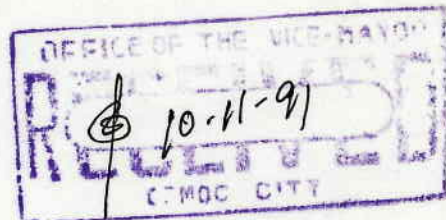

RESOLUTION NO. 122

A RESOLUTION EARNESTLY REQUESTING THE NEA ADMINISTRATOR
RODRIGO CABRERA FOR ADDITIONAL FINANCIAL ASSISTANCE TO
LEYECO V FOR THE PURCHASE OF ELECTRICAL CONSTRUCTION
MATERIALS.

WHEREAS, on a Conference with LEYECO V Officials relative to the
Expansion of Electricity not only in Ormoc City but also to the whole
district under the jurisdiction and responsibilities of LEYECO V, the
Honorable City Mayor of Ormoc has requested some city officials to make
visitations and ocular inspections on surrounding barangays of Ormoc and
confer directly with barangay officials/folks about their problems on
electricity. (at this juncture, a Representative from the Office of the
Congressman (4th District - Leyte), has also emphasized the following
places under District 4 where electric posts and wirings are badly
needed: Brgy. Sta. Rosa, Matag-ob, Leyte; Brgys. Tagaytay and
Hiloktugan, Kananga, Leyte; Lundag, Merida, Leyte; Kantuhawon, Magsaysay
and Kanipaan in Palompon, Leyte; Hunan in Isabel, Leyte, and Brgy.
Salvacion in Albueria, Leyte);

WHEREAS, up to now, barangay electrification still remains a
problem, with many barangay officials from different barangays in Ormoc
City, (to mention some, from Barangays Nueva Vista, Domonar,
Guintiguian, Catmon, Manlilinao, Valencia (at Sitio Quinlimhan) and
Mabini (where the venue of a proposed Golf Course is officially
planned), have been requesting that their respective barangays be
furnished with proper electricity, meaning, that electric poles be
posted and lines or electrical wirings be connected through to their
barangays;

WHEREAS, the Management of LEYECO V, this city, has officially
informed this august Body, through the Honorable Office of the City
Mayor, that although financial assistance for electrical construction
materials has been released to said establishment, the same is not

enough to cope up with the desired Programs of Work of LEYECO V especially on barangay electrification;

WHEREAS, for the interest of public service and general welfare, ours is indeed to relish a thought on providing electric light to our barangay folks who have been neglected and forgotten, one way or another;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Vice Chairman, Committee on Energy Development and Conservation, jointly seconded by mga Kagawad Nelson DL. Geneston and Antero T. Fiel; be it




