RESOLUTION NO. 130

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EFFECT AN  
INTER-FUND TRANSFER IN THE AMOUNT OF P250,000.00 FROM THE  
UNAPPROPRIATED SURPLUS OF THE GENERAL FUND TO  
INFRASTRUCTURE FUND FOR FUNDING PURPOSES OF TWO (2) BASIC  
SERVICES UNDER THE INFRASTRUCTURE FUND, NAMELY, A) GARBAGE  
COLLECTION AND DISPOSAL AND B) MAINTENANCE OF PARKS AND  
PLAZAS.

WHEREAS, this august Body is in receipt of a letter dated 16  
September 1991 from the City Engineer through the Honorable Office of  
the City Mayor, said letter has requested for additional appropriation  
of P250,000.00 for two (2) basic services, namely, a) Garbage Collection  
and Disposal and b) Maintenance of Parks and Plazas, with its attached  
computations on detailed estimates as follow:

A) GARBAGE COLLECTION AND DISPOSAL

24 laborers for 22 days/mo. @ P86.36/day  
= P45,598.08/mo.  
= P547,176.96/year  
SAY = P550,000.00  
Less: Current Appr. = 450,000.00

ESTIMATED COST P100,000.00

B) MAINTENANCE OF PARKS AND PLAZAS

Estimated Labor Cost & Misc. Materials,  
etc. from Sept. 1, 1991 to December  
31, 1991 @ P50,000.00/mo.  
= P200,000.00  
Less: Bal. of current  
Appr. 9/31/91 = 58,580.87

WHEREAS, due to financial constraints of the Infrastructure Fund at this point in time, necessitating, therefore, the movement of funds from the Unappropriated Surplus of the General Fund to the Infrastructure Fund for funding purposes of the aforesaid two (2) basic services under the Infrastructure Fund;

WHEREAS, an Inter-Fund transfer is authorized under the Budget Operations Manual for Local Governments, specifically Section 3.19 (4) thereof;

NOW, THEREFORE on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Gregorio A. Yrastorza, Jr., be it


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer to effect an Inter-Fund transfer in the amount of P250,000.00 from the Unappropriated Surplus of the General Fund to the Infrastructure Fund for funding purposes of two (2) basic services under the Infrastructure Fund, namely, a) Garbage Collection and Disposal and b) Maintenance of Parks and Plazas;

CARRIED UNANIMOUSLY.


