RESOLUTION NO. 135

A RESOLUTION EARNESTLY REQUESTING THE SOCIAL SECURITY SYSTEM
(SSS) TO INCREASE THE AMOUNT OF LOAN (CALAMITY LOAN) TO
MEMBERS WHO WERE VICTIMS OF TYPHOON "URING" EQUIVALENT TO
FIVE (5) MONTHS SALARY AND TO FOREGO WITH THE
DISQUALIFYING CONDITIONS.

WHEREAS, on a fateful noontime of November 5, 1991, typhoon Uring
mercilessly unleashed her fury in Leyte province, particularly in Ormoc
City, causing tremendous flood resulting to the death of thousands of
Ormocanons, injuries to another thousands, with enormous damages to
properties and infrastructures and rendering countless Ormocanons
homeless or became refugees;

WHEREAS, among the many private and government entities or agencies
which have responded help or assistance to Ormoc City, the Social
Security System has thus granted Calamity Loan to the Members thereof
who were affected by said catastrophe;

WHEREAS, this august Body, however, believes that the loanable
amounts are not enough, more so that the proceeds of said loanable
amounts are subject to deductions on outstanding balances, and, that the
term of the loan is short or less reasonable;

WHEREAS, this august Body highly requests that this Calamity Loan
should be treated a separate loan for those who have outstanding
balances with SSS;

NOW, THEREFORE, on motion of Kagawad Nelson DL. Geneston,
Chairman, Committee on Industrial Labor, jointly seconded by mga Kagawad
Celso P. Adolfo and Edgar Z. Palugod; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE SOCIAL
SECURITY SYSTEM (SSS) TO INCREASE THE AMOUNT OF LOAN (CALAMITY LOAN) TO



CARRIED UNANIMOUSLY.


