RESOLUTION NO. 136

A RESOLUTION HIGHLY REQUESTING THE HONORABLE CITY MAYOR MA. VICTORIA L. LOCSIN TO PLACE A BILLBOARD NEAR THE CAPITOL BUILDING IN CEBU CITY WITH LITERATURES EXPRESSING OUR MOST PROFOUND GRATITUDE AND SINCEREST THANKS TO THE CITY GOVERNMENT OF CEBU, THE PROVINCIAL GOVERNMENT OF CEBU, AND THE PEOPLE OF CEBU FOR THEIR SUPPORT AND ASSISTANCE IN ORMOG CITY WHICH WAS VERY HEAVILY DAMAGED BY TYPHOON "URING".

WHEREAS, on a fateful noontime of November 5, 1991, typhoon Uring mercilessly unleashed her fury in Leyte province, particularly in Ormoc City, causing heavy and very strong flood, resulting the death of thousands of Ormocanons, declared missing to the thousands, injuries to another thousands, with enormous damages to properties and infrastructures and rendering countless Ormocanons homeless or became refugees;

WHEREAS, the City Government of Cebu, the Provincial Government of Cebu and the civic and public spirited Cebuanos were among the first and earliest rescue operations teams to have responded and rendered the much needed humanitarian assistance and services in Ormoc City which was terribly damaged, in terms of lives and properties, by the said monstrous storm;

WHEREAS, this august Body has considered these good Samaritan help, services and accomplishments done by the Cebuanos very monumental and much worthy to reckon with, therefore, must deserve a genuine acknowledgment of its meaning and importance on the part of the City Government of Ormoc;

NOW, THEREFORE, on motion of Kagawad Celso P. Adolfo, UNANIMOUSLY seconded by all other mga Kagawad present, be it
