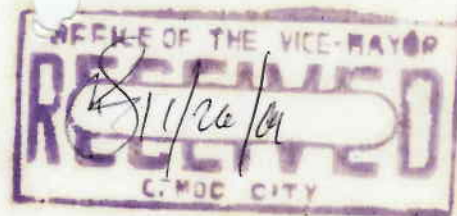

RESOLUTION NO. 139

A RESOLUTION EARNESTLY SUPPORTING AND HIGHLY ENDORSING THE REQUEST OF THE HONORABLE CONGRESSMAN CORNELIO P. MASKARIMO, 2ND DISTRICT, DAVAO CITY, SETTING ASIDE P1-MILLION OUT OF HIS P10-MILLION COUNTRYSIDE DEVELOPMENT FUND FOR 1992 FOR DISTRIBUTION AS FOLLOWS: A) FOR ORMOC CITY THROUGH CITY MAYOR - P500,000.00, B) FOR ALBUERA, LEYTE THROUGH MUNICIPAL MAYOR - P200,000.00, C) FOR BURAUEN, LEYTE THROUGH THE MUNICIPAL MAYOR - P200,000.00, AND D) FOR NEGROS OCCIDENTAL THROUGH THE PROVINCIAL GOVERNOR - P100,000.00.

WHEREAS, a letter dated 11 November 1991 from Honorable Cornelio P. Maskarimo, Congressman, 2nd District, Davao City, addressed Her Excellency, President Corazon C. Aquino, Malacañang, Manila, has been presented to this august Body through the Honorable Vice Mayor & Presiding Officer, requesting for support and endorsement, the full text of said letter is hereunder cited as follows:

Dear Mrs. President:

First of all allow me to express my thanks for the deep concern and your help extended to victims of "Uring" in Ormoc City and other parts of Leyte. For your information Mrs. President, I am from the town of Albuera, a former barrio of Ormoc, and I studied in the Intermediate and High School in Ormoc City.

Mrs. President, for the victims of Mt. Pinatubo, every member of Congress was asked to set aside from his Congressional allocation P500,000.00. I readily agreed to sign the required conformity as a manifestation of the Christian compassion and charity.

Mrs. President, I would like to help the victims in Ormoc City, Leyte and Negros same as I helped the victims of Mt. Pinatubo. I would respectfully request that I be allowed to set aside P1 Million of my P10 Million Countryside Development fund for 1992, for distribution as follows:

For Ormoc City thru City Mayor.....	P/500,000.00
For Albuera, Leyte thru the Municipal Mayor.....	200,000.00
For Burauen, Leyte thru the Municipal Mayor.....	200,000.00
For Negros Occidental thru the Provincial Governor.....	100,000.00
TOTAL.....P1,000,000.00

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Celso P. Adolfo and Sixto T. Pongos; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly support and highly endorse the request of the Honorable Congressman Cornelio P. Maskariño, 2nd District, Davao City, to set aside P1-Million out of his P10-Million Countryside Development Fund for 1992 for distribution as follows: a) for Ormoc City through City Mayor - P500,000.00, b) for Albuera, Leyte through Municipal Mayor - P200,000.00, c) for Burauen, Leyte through Municipal Mayor - P200,000.00, and d) Negros Occidental through the Provincial Governor - P100,000.00;
