A RESOLUTION EARNESTLY REQUESTING CONGRESS THROUGH SPEAKER  
RAMON V. MITRA TO ALLOW CONGRESSMEN TO SET ASIDE A CERTAIN  
AMOUNT FROM THEIR COUNTRYWIDE DEVELOPMENT FUND AS CALAMITY  
AID FOR ORMOC CITY.

Officer to request Congress for the Congressmen to allocate out of their  
Countrywide Development Fund a sum of money for Ormoc.


