RESOLUTION NO. 15

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), THROUGH ITS REGIONAL DIRECTOR, REGION VIII, TACLOBAN CITY, TO ALLOW THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P8,500.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND (EDF) TO BE MADE AVAILABLE AS ORMOC CITY'S COUNTERPART FUND FOR THE CLUSTER CONSULTATIVE COUNCIL (CCC) (ORMOC, ALBUERA AND KANANGA) OPERATIONS.

WHEREAS, for consideration of this august Body is a request for an appropriation in the amount of Eight Thousand Five Hundred Pesos (P8,500.00) as Ormoc City's counterpart fund for the Cluster Consultative Council (CCC) (Ormoc, Albueria and Kananga) Operations;

WHEREAS, the City Budget Officer has recommended that funding for this purpose be taken from the 20% Economic Development Fund (EDF) of the General Fund, subject, however, to a request for authorization from the Department of Interior and Local Government (DILG) pertaining to utilization of the said amount;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has enacted Resolution No. 14 embodying Appropriation Ordinance No. 91-05 (copy of same is hereto attached), approving IN PRINCIPLE of an appropriation of EIGHT THOUSAND FIVE HUNDRED PESOS (P8,500.00) from out of the 20% ECONOMIC DEVELOPMENT FUND (EDF) said amount or so much thereof as maybe necessary, to be made available as Ormoc City's counterpart fund for the Cluster Consultative Council (CCC) operations, subject, however, to a request for authorization from the Department of Interior and Local Government (DILG) pertaining to utilization of the said amount;
