

RESOLUTION NO. 150

A RESOLUTION AUTHORIZING THE CLTY TREASURER TO EFFECT AN INTER-FUND TRANSFER IN THE AMOUNT OF P100,000.00 FROM THE UNAPPROPRIATED SURPLUS OF THE GENERAL FUND TO INFRASTRUCTURE FUND FOR PAYMENT OF WAGES OF (CASUAL FINISHED OF MAINTENANCE HIRED IN THE INFRASTRUCTURE PROJECTS COVERING THE PERIOD FROM TO DECEMBER 1991.

WHEREAS, this august Body is in receipt of a letter dated 27 November 1991 from the City Engineer requesting for an appropriation of P100,000.00 to cover wages of casual employees hired in the maintenance of finished Infra Projects for the period November to December 31, 1991.

WHEREAS, due to the financial constraints of the Infrastructure Fund at this point in time, necessitating therefore, the movement of funds from the Unappropriated Surplus of the General Fund to the Infrastructure Fund for payment of wages of casual employees hired in the maintenance of finished Infra Projects covering the period November to December 31, 1991.

WHEREAS, an Inter-Fund Transfer is authorized under the Budget Operation Manual for Local Governments, specifically Section 3.19 (4) thereof

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer to effect an Inter-Fund transfer in the amount of F100,000.00 from the Unappropriated Surplus of the General Fund to the Infrastructure Fund for payment of wages of casual employees hired in the maintenance of
