

## RESOLUTION NO. 151

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EFFECT AN TRANSFER FROM THE UNDERESTIMATED INTER-FUND REVENUE ALLOTMENT FOR CY 1991 TO THE INFRASTRUCTURE FUND IN THE AMOUNT OF P177,000 OO FOR CALAMITY AID TO REGULAR AND CASUAL EMPLOYEES OF THE CITY GOVERNMENT OF ORMOC FUNDED UNDER THE INFRASTRUCTURE FUND.

WHEREAS, this august Body is in receipt of an indorsement from the City Budget Office requesting to authorize the City Treasurer to make an Inter-Fund Transfer in the amount of P177,000.00 as Calamity Aid to regular and casual employees of the City Government funded under the Infrastructure Fund;

WHEREAS, due to the financial constraints of the Infrastructure Fund at this point in time, necessitating therefore, the movement of funds from the Underestimated Internal Revenue Allotment for CY 1991 to the Infrastructure Fund for this purpose;

an Inter-Fund Transfer is authorized under the Budget Operation Manual for Local Governments, specifically Section 3. 19 (4) thereof;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Gregorio A. Yrastroza, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer to effect an Inter-Fund Transfer in the amount of P177,000.00 from the Underestimated Internal Revenue Allotment for CY 1991 to the Infrastructure Fund for Calamity Aid to regular and casual employees of the city government funded under the Infrastructure Fund.
