FELIX MAZO OF ORMOC CITY, TO ALLOW DEDUCTIONS ON WITHHOLDING TAX ON SALARIES OF CITY GOVERNMENT EMPLOYEES OF ORMOC ON STAGGERED BASIS DUE TO THE DEVASTATION BROUGHT ABOUT BY TYPHOON "URING" CAUSING UNTOLD DAMAGES TO LIVES AND PROPERTIES.
