## RESOLUTION NO. 153

EARNESTLY REQUESTING HER EXCELLENCY, A RESOLUTION PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, CORAZON C. AQUINO, AND THE COMMISSIONER OF THE BUREAU OF INTERNAL REVENUE, JOSE U. ONG, TO GRANT TAX AMNESTY TO BUSINESSMEN, PROFESSIONALS, GOVERNMENT AND PRIVATE EMPLOYEES, SUGAR PLANTERS AND OTHER SELF-EMPLOYED PERSONS, FOR THE YEAR 1990-91 AND TO EXEMPT FROM EXAMINATION THE BOOKS OF ACCOUNTS FOR THE YEAR 1989, 1990, 1991 BECAUSE OF THE DAMAGES SUFFERED BY THE ORMOCANONS DURING THE FLASHFLOOD BROUGHT BY TYPHOON "URING" LAST NOVEMBER 5, 1991.

WHEREAS, this august Body is in receipt of resolution no. 2 of the Ormoc Filipino Retailer's Association, Inc. entitled "A resolution Earnestly Requesting the Bureau of Internal Revenue through the Honorable City Mayor of Ormoc for Tax Amnesty to businessmen for the year 1990-1991 and also the Books of Accounts be exempted from examination for the year 1989, 1990, 1991 because of the Damages suffered by the Ormocanons during the Flashflood of Typhoon "Uring" last November 5, 1991. The records were washed out and damaged.

WHEREAS, the Ormoc Filipino Retailer's Association, Inc. whose members are businessmen, suffered damges and losses brought about by Typhoon "Uring" which destroyed many business establishments, stocks, residential houses including records, books of accounts which are requirements for the procurement/payment of business permits/licenses.
