RESOLUTION NO. 154

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC, MA. VICTORIA L. LOCSIN TO NEGOTIATE AND ENTER INTO A CONTRACT OF SALE WITH ENGR. ARTURO PANTINO, MRS. JUANA DAFFON AND MR. ARMANDO GO WHO HAVE INDICATED THEIR DESIRE TO SELL PART OF THEIR LOTS FOR PERMANENT RELOCATION SITES FOR THE SEVERAL FAMILIES WHO WERE RENDERED TOTALLY HOMELESS BY TYPHOON "URING".

WHEREAS, this august Body is in receipt of a letter from the Honorable City Mayor requesting for an authority from said august Body to negotiate and enter into a contract of sale with Engr. Arturo Pantino, Mrs. Juana Daffon and Mr. Armando Go, who have indicated their desire to sell part of their lots for this purpose;

WHEREAS, the City Government of Ormoc in coordination with various agencies of the national Government and Several Non-Governmental Organizations (NGO's) is presently preparing permanent relocation sites for the several families who were rendered totally homeless.

WHEREAS, these agencies including the NGO's will only spend for the construction of the houses but not the acquisition of the necessary lots.

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, jointly seconded by Kagawad Celso P. Adolfo; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor, Ma. Victoria L. Locsin, to negotiate and enter into a contract of sale with Engr. Arturo Pantino, Mrs. Juana Daffon and Mr. Armando Go who have indicated their desire to sell part of their lots for permanent relocation sites for the several families who were rendered totally homeless by typhoon "Uring".
