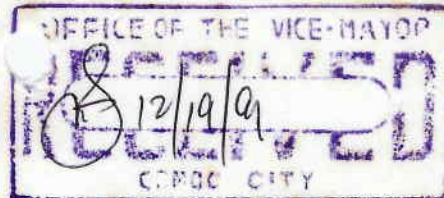

as expressed through Resolution No. 156 s. 1991;

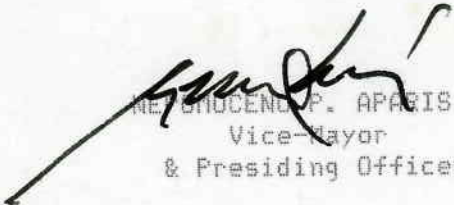
NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr.,
