RESOLUTION NO. 158

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EFFECT AN INTER-FUND TRANSFER OF P65,000.00 FROM THE UNDERESTIMATED INTERNAL REVENUE ALLOTMENT (IRA) FOR CY 1991 TO THE INFRASTRUCTURE FUND AS ADDITIONAL CALAMITY AID TO CASUAL EMPLOYEES UNDER THE INFRASTRUCTURE FUND.

WHEREAS, Her Honor, the City Mayor, through a letter dated 16 December 1991, has requested this august Body for additional aid to casual employees in the government who were also badly affected by the killer-flood brought about by typhoon Uring;

WHEREAS, P65,000.00 is supposedly needed as additional aid to casual employees under the Infrastructure Fund;

WHEREAS, due to financial constraints of the Infrastructure Fund at this point in time, necessitating, therefore, the movement of funds from the Underestimated Revenue Allotment (IRA) for CY 1991 to the Infrastructure Fund for funding purposes relative the aforecited request of the Honorable City Mayor;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, duly seconded by Kagawad Arnulfo C. Salazar; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer effect an Inter-Fund Transfer in the amount of P65,000.00 from the Underestimated Internal Revenue Allotment (IRA) for CY 1991 to the In rastructure Fund as additional calamity aid to casual employees under the Infrastructure Fund.
