

RESOLUTION NO. 16

A RESOLUTION AUTHORIZING THE HONORABLE PRESIDING OFFICER OF THE SANGGUNIANG PANLUNGSOD TO APPOINT A COMMITTEE TO TAKE CHARGE IN THE INVESTIGATION OF A COMPLAINT ON ABANDONMENT OF OFFICE OF THE PUNONG BARANGAY OF BARANGAY DON POTENCIANO LARRAZABAL, THIS CITY, AS LODGED BY MEMBERS OF THE BARANGAY COUNCIL OF SAID BARANGAY.

WHEREAS, thas august Body is in receipt of a Complaint on Abandonment of Office of the Punong Barangay of Barangay Don Potenciano Larrazabal, duly subscribed and signed by the Members of the Barangay Council of said barangay, as complainants;

WHEREAS, the same Barangay Council has presented Barangay Resolution No. 15 s. 1991 narrating the facts and circumstances allegedly in support of their complaint;

WHEREAS, Honorable Brenda Castillo, Punong Barangay of Barangay Don otenciano La razabal has allegedly incurred an unauthorized absence of about six (6) months;

WHEREAS, under Sec. 60 Par. 6 of Batas Pambansa Blg. 337, otherwise mown as the Local Government Code, one ground for the suspension or removal from office of an elective barangay official is an unauthorized absence for three (3) consecutive months which is tantamount to bandonment of office; and

WHEREAS, said Local Governdment Code also grants the power or authority to this august Body to investigate matters of this nature;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, duly seconded by Kagawad Gregorio A. Yrastorza, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable Presiding Officer of the Sangguniang Panlungsod ng Ormoc to appoint a Committee to take charge in the investigation of a Complaint on Abandonment of Office of the Punong Barangay of Barangay Don Potenciano Larrazabal, as lodged by Members of the Barangay Council of said barangay;

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor, the Honorable SP Kagawad-In-Charge of Barangay Don Potenciano Larrazabal, the Honorable ABC President, the City Legal Officer and the Secretary of Barangay Don Potenciano Larrazabal Council, - all in Ormoc City;
