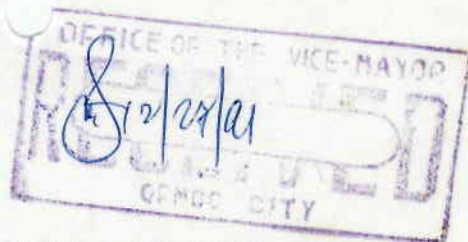

RESOLUTION NO. 164

A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE PORTS
AUTHORITY (PPA) TO UNDERTAKE THE REHABILITATION OF THE
DRAINAGE SYSTEM AT THE PIER AREA OF ORMOC.

WHEREAS, this august Body is in receipt of a letter from Her Honor, the City Mayor, dated 16 December 1991, the 1st Paragraph of said letter has stated, thus: "Our portion of the drainage system for the Terminal area which used to flow out toward the sea at the side of the pier has been diverted by the Philippine Ports Authority when they filled up their compound. As a result, drainage in that area is now inadequate." And, has requested this august Body for a resolution urging PPA to include in their program of repairs the drainage system at pier area which they have diverted;

WHEREAS, since Philippine Ports Authority is currently in the process of several projects to improve the port facilities as well as their compound, and, the City Government of Ormoc feels that PPA could assist us for more, considering that the aforementioned defect was incurred by them;

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., jointly seconded by mga Kagawad Celso P. Adolfo and Celso P. Porcadilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request the Philippine Ports Authority (PPA) to undertake the rehabilitation of the drainage system at the pier area of Ormoc;
