NOW HELD IN TRUST BY THE CITY GOVERNMENT OF ORMOC TO A
SEPARATE ACCOUNT IN THE NAME OF THE CITY DISASTER
COORDINATING COUNCIL.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in
receipt of Resolution No. 9 s. 1991 of the City Disaster Coordinating
Council (CDCC), earnestly requesting this august Body for approval of
the transfer of all cash donations received for typhoon Uring victims
which are currently held in trust by the City Government of Ormoc to a
separate account in the name of the City Disaster Coordinating Council;

rehabilitation program being undertaken by the City Disaster
