RESOLUTION NO. 17

A RESOLUTION AUTHORIZING THE HONORABLE PRESIDING OFFICER OF THE SANGGUNIANG PANLUNGSOD TO DESIGNATE A COMMITTEE TO INVESTIGATE A COMPLAINT ON ALLEGED ABANDONMENT OF OFFICE OF KAGAWAD ARSENIO AMO, JR. OF BARANGAY DON FELIPE LARRAZABAL, HOWEVER, MEANTIME, TO REQUIRE THE SECRETARY OF SAID BARANGAY COUNCIL TO SUBMIT A VERIFIED COMPLAINT SIGNED BY THE COUNCIL MEMBERS AS A NECESSARY ATTACHMENT TO THEIR SUBMITTED RESOLUTION NO. 17.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of Resolution No. 17 s. 1991 of the Barangay Council of Barangay Don Felipe Larrazabal, requesting this august Body to charge Kagawad Arsenio Amo, Jr. of said Council for alleged Abandonment of Office;

WHEREAS, Hon. Arsenio Amo, Jr., Barangay Kagawad of Barangay Don Felipe Larrazabal, has allegedly incurred unauthorized absences in Council's meetings despite earnest efforts exerted for him to report;

WHEREAS, under Sec. 60 Par. 6 of Batas Pambansa Blg. 337, otherwise known as the Local Government Code, one ground for the suspension or removal from office of an elective barangay official is an unauthorized absence for three (3) consecutive months which is tantamount to abandonment of office; and

WHEREAS, the same Code also grants power or authority to this august Body to investigate matters of this nature;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, duly seconded by Kagawad Gregorio A. Yrastorza, Jr., be it


