RESOLUTION NO. 172

A RESOLUTION SINCERELY THANKING HER EXCELLENCY, PRESIDENT
CORAZON C. AQUINO, FOR HER BENEVOLENCE AND PUBLIC
SPIRITEDNESS IN GIVING SUPPORT AND ASSISTANCE IN TERMS OF
CASH AND IN KINDS TO ORMOC CITY WHICH WAS HEAVILY DAMAGED
BY TYPHOON URING.

WHEREAS, on a fateful noontime of November 5, 1991, typhoon Uring
mercilessly unleashed her fury in Leyte Province, particularly in Ormoc
City, causing a very strong flood with turbulent waters surging the
streets of the city at the height of the flashflood, resulting the
death of thousands of Ormocanons, declared missing to the thousands,
injuries to another thousands, with enormous damages to properties and
infrastructures and rendering countless Ormocanons homeless or became
refugees;

WHEREAS, Her Excellency, President Corazon C. Aquino and PARTY who
had personally come to Ormoc City to conduct the desired ocular
investigation of the actual ruins of the place, had immediately rendered
humanitarian assistance and services in cash and in kinds to the flood
victims, in particular, and to the heavily damaged Ormoc City, in
general;

WHEREAS, this august Body has acknowledged with utmost gratitude
the laudable gestures of public consciousness and benevolence of the
distinguished President of the Republic of the Philippines;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon,
UNANIMOUSLY seconded by all other mga Kagawad present, be it

RESOLVED, to pass a resolution SINCERELY THANKING HER EXCELLENCY

WAS HEAVILY DAMAGED BY TYPHOON URING;


