RESOLUTION NO. 18

A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 039 S. 1991 OF THE SANGGUNIANG PANLUNGSOD NG BAKOLOD, BACOLOD CITY, SAID RESOLUTION HAVING STRONGLY SUPPORTED SENATE BILL NO. 1701, ENTITLED "AN ACT FIXING THE DATE OF THE LOCAL ELECTIONS AND FOR OTHER PURPOSES", INTRODUCED BY SENATOR ALBERTO G. ROMULO, WITH PARTICULAR EMPHASIS ON THE FOLLOWING POINTS, A) THE HOLDING OF SEPARATE ELECTIONS WITH THE NATIONAL ELECTIONS SCHEDULED AHEAD OF LOCAL ELECTIONS, AND B) THE LOCAL OFFICIALS ELECTED JANUARY 1988 SHALL HOLD OFFICE UNTIL THEIR SUCCESSORS SHALL HAVE BEEN ELECTED AND QUALIFIED.

WHEREAS, this august Body is in receipt of Resolution No. 039 s. 1991 of the Sangguniang Panlungsod ng Bakolod, which resolution having strongly supported Senate Bill No. 1701, entitled "An Act fixing the date of the Local Elections and for other purposes", introduced by Senator Alberto G. Romulo, with particular emphasis on the following points, a) the holding of separate elections with the National Elections scheduled ahead of Local Elections, and b) the local officials elected January 1988 shall hold office until their successors shall have been elected and qualified;
