RESOLUTION NO. 21

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO UTILIZE LOTS NOS. 5362-A, 5362-B, 5362-C AND 5362-D WITH A TOTAL AREA OF 40,091 SQUARE METERS AND OWNED BY THE CITY GOVERNMENT FOR A JOINT VENTURE WITH THE NATIONAL HOUSING AUTHORITY IN THE DEVELOPMENT OF A HOUSING PROJECT FOR THE CITY GOVERNMENT EMPLOYEES.

WHEREAS, the City Government of Ormoc has purchased parcels of land, Lots Nos. 5362-A, 5362-B, 5362-C and 5362-D with a total area of 40,091 square meters, situated at Barangay San Isidro, this city, said lands are intended to be used in connection with the Housing Project for the city government employees, as programmed by the City Government;

WHEREAS, this august Body is in receipt of a letter dated 5 March 1991 from the Honorable City Mayor requesting for an authorization to utilize the aforesaid lots for a joint venture or undertaking with the NHA in the development of a housing project for the city government employees;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has considered this request of the City Mayor very laudable and in keeping with the Program of the City Government on providing house and lot to the employees at supposedly reasonable amortization payments;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Infrastructure, duly seconded by Kagawad Nelson DL. Geneston; be it


