RESOLUTION NO. 22

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE WITH ANY PRIVATE DEVELOPER WHO MAY BEST FIT TO WORK OR DEVELOP THE HOUSING PROJECT AT BARANGAY SAN ISIDRO, ORMOG CITY, FOR THE CITY GOVERNMENT EMPLOYEES.

WHEREAS, through a letter dated 5 March 1991, the Honorable City Mayor has requested, among others, for an authority to negotiate with any private developer in the development of a Housing Project at Barangay San Isidro, this city, for the city government employees;

WHEREAS, Resolution No. 21 s. 1991 has authorized the City Mayor to utilize parcels of land owned by the City Government, (Lots Nos. 5362-A, 5362-B, 5362-C and 5362-D with a total area of 40,091 square meters), for a joint venture with the National Housing Authority in the development of the aforecited housing project for government employees;

WHEREAS, this request for authority to negotiate with a private developer to work out or put into being the said housing project is an important requirement needed by NHA in connection with a joint venture of the City Government with that Office appertaining this housing project;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Infrastructure, duly seconded by Kagawad Nelson DL Geneston; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE WITH ANY PRIVATE DEVELOPER WHO MAY BEST FIT TO WORK OUT OR DEVELOP THE HOUSING PROJECT AT BARANGAY SAN ISIDRO, ORMOG CITY, FOR THE CITY GOVERNMENT EMPLOYEES;
