A RESOLUTION REQUESTING THE COMMANDING OFFICER OF 352ND PC COMPANY AND THE STATION COMMANDER OF ORMOC INP (PNP) TO CONDUCT ROUTINARY PATROLS IN SOME BARANGAYS AND OTHER STRATEGIC AREAS IN ORMOC CITY BELIEVED WITH QUESTIONABLE ELEMENTS OF THE DISSIDENTS.

WHEREAS, on different dates of this year, a series of sugar cane burning have occurred in different haciendas of big time hacienderos in Ormoc City which to mention some, those of Don Potenciano Larrazabal, Judge Benjamin Pongos, Mrs. Cecilia Torres, the ASPRAC Agricultural Corporation, Mr. Hermie Serafica, the A. Tan's Farm, and many more, and, it is the perception of many hacienderos that these wanton acts are allegedly the work of the elements of NPA, trying to sabotage the sugar cane industry in Ormoc;

WHEREAS, the burning of sugar cane plantations are so indiscriminate, with young sugar canes burned, plants not yet ready for milling;

WHEREAS, these raw, rotten and malicious acts committed by the dissidents and other misguided elements of society must not be left unchecked, to the point be reduced to the minimum, otherwise, peace and orderliness of the place would be greatly jeopardized;


