RESOLUTION NO. 25

A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, TO GRANT THE CITY GOVERNMENT OF ORMOC AN EXEMPTION FROM COMPLIANCE OF THE PROVISIONS OF ADMINISTRATIVE ORDER NO. 205 ON AGENCY STAFF REDUCTION AND REDEPLOYMENT PROGRAMS.

WHEREAS, the underlying provisions of Administrative Order No. 205, as further elucidated relative its guidelines and procedures of implementation by DBM Dircular No. 421 s. 1991, are indeed hearty with the good intentions of the government to promote provisions imbue efficient organizational structure and to ultimately cause into effect economic reasures in all agencies and instrumentalities thereof;

WHERE'S, however, the City Government of Ormoc, through its Personnel Reorganization Program being effected last year, had made the desired reduction of its employees in different offices with the aims in New on achieving efficient organizational set up with minimum expense the part of the city and, thereafter, the optimal utilization of its ing manpower;

AS, the current organization1 set up to the city government is sured with the conception of a desired organization structure, with offices and positions thereof having their necessary relevance, with personnel enough and sufficient to command and demand efficient services and, the City can well afford giving the salaries and other penefits to its employees;

WHEREAS, to go along with the reduction and redeployment of the present Agency Staff in Ormoc City, these programs are not advisable this time, for they would instead prejudice the efficient functions of the city government;
