RESOLUTION NO. 32

A RESOLUTION EARNESTLY REQUESTING LEYECO V, THROUGH ITS GENERAL
MANAGER, TO INSTALL TRANSMISSION LINE OF ELECTRICITY FROM BARANGAY
SAN JOSE (PROPER) TO MGA PUROK POINSETTIA AND ZENIAS OF THE SAME
BARANGAY.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of
Resolution No. 2 s. 1991 of Barangay San Jose, this City, requesting for
passage of a resolution, addressed LEYECO V, for continuance of the
"installation of electric power from Barangay San Jose proper to Purok
Poinsettia and Purok Zenias of Barangay San Jose, in order that the
residents of the said (mga) purok can avail (of) the benefits of the
electric power", and, a copy of their resolution (said Resolution No.
2) has been furnished the Manager, LEYECO V;

WHEREAS, it is alleged that a transmission line has been installed
only up to the residence of the late Brgy. Captain Solomon Chu of said
barangay, therefore denying the residents of mga Purok Poinsettia and
Zenias of their long dreamed and cherished aspiration to possess
electric light in their homes and immediate vicinities;

WHEREAS, through the representation of the Honorable SP Kagawad-in-
Charge for barangay San Jose, it has been disclosed that among the mga
Purok of said barangay, only these two (Purok Poinsettia and Purok
Zenias) are up to now not energized for one reason or another;

WHEREAS, it could be a delightful, pleasing and very commendable
gesture of public service should LEYECO V take heed and spare favor to
this hearty and valid request of the residents of said mga Purok of
Barangay San Jose for electricity;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Kagawad In-Charge for San Jose, jointly seconded by mga Kagawad Edgar Z. Palugod and Nelso DL. Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request LEYECO V, through its General Manager, to install transmission line of electricity from Barangay San Jose proper to mga Purok Poinsettia and Zenias belonging to the same barangay;

ENACTED, April 4, 1991.

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor, the General Manager - LEYECO V, the ABC President, the Honorable Punong Barangay of Barangay San Jose and a special copy to the President - LEYECO V, - all in Ormoc City;
