

RESOLUTION NO. 35

A RESOLUTION MOST PROFOUNDLY THANKING THE PROVINCIAL GOVERNMENT OF LEYTE THROUGH THE HONORABLE GOVERNOR ADELINA Y. LARRAZABAL FOR THEIR BENEVOLENCE IN GIVING FINANCIAL ASSISTANCE TO THE FIRE VICTIMS IN ORMOC CITY.

WHEREAS, a huge fire had taken place last January 16, 1991, razing clusters of houses in a thickly populated border district of Barangays Don Felipe Larrazabal and Alegria, this city, leaving an elderly woman dead, injuries to some and untold miseries to many with hundreds of families having lost their homes;

WHEREAS, the City Government, aside being engrossed on providing relief assistance to the fire victims, had made public appeals for help, for sympathy to the plight of the helpless and unfortunate victims of said conflagration;

WHEREAS, many benevolent and civic spirited persons and entities had responded to the public call for help and assistance, and, by April 4, 1991 in the morning, no less than the distinguished Leyte Governor, Honorable Adelina Y. Larrazabal and Party, had visited Ormoc City and, at the Honorable Placido Enecio Hall of the Sangguniang Panlungsod ng Ormoc, had personally distributed cash donations at P500.00 each to fire victims who had jampacked themselves at said place, extremely delighted and much thankful on receiving their shares and on knowing the bigness of the heart of the distinguished governor;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has considered the financial assistance given to fire victims by the Honorable Governor of Leyte as an emulative example of magnanimity and public-spiritedness, so laudable and much commendable, hence, must be accorded with due course and immediate action;
