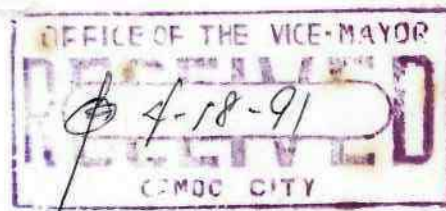

RESOLUTION NO. 36

A RESOLUTION ENDORSING AS VALID AND MERITORIOUS THE REQUEST OF
BARANGAY COUNCIL DISTRICT XVI, THIS CITY, ON RE-ENACTING A CITY
ORDINANCE DECLARING AGUA DULCE STREET A ONE-WAY STREET, HOWEVER,
SAID REQUEST BE ENDORSED MEANTIME TO THE SECRETARY OF PUBLIC WORKS
AND HIGHWAYS FOR APPROVAL, FOR AGUA DULCE STREET BEING A NATIONAL
ROAD, BY LAW, ONLY THE DPWH SECRETARY CAN DECLARE IT A ONE-WAY
STREET.

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of
Resolution No. 014 s. 1991 from the Barangay Council of District XVI,
this city, requesting, through the Office of the City Mayor, for
reenactment of a City Ordinance making Agua Dulce Street a one-way road
to protect school children in going to and coming from schools and as a
safety precaution to the barangay folks against road hazards;

WHEREAS, many years ago, the First Sangguniang Panlungsod ng Ormoc
had enacted Ordinance No. 23 through Resolution No. 725-A s. 1979
declaring Agua Dulce Street a one-way street, from its corner on San
Pablo Street up to its opposite corner on C. Aviles Street, on grounds
of safety and convenience to all concerned, for said street was and
still is narrow and hardly could accommodate the heavy flow of cargo
trucks and other vehicles passing through it;

WHEREAS, due to the passage of time up to now, an element of doubt
as to the feasibility of re-enacting said City Ordinance has cropped
up, so that the Honorable Chairman, Committee on Laws and Ordinance, has
endorsed the aforementioned resolution of Barangay Council District XVI
jointly to the City Engineer and the Station Commander, Ormoc PNP, for
their respective comments and recommendations;

(RES. NO. 36, S. 1991)

WHEREAS, both Indorsements dated March 18, 1991 and April 3, 1991 from the City Engineer and the PNP Station Commander, respectively, give comments that Agua Dulce Street in Ormoc City is a national road, to the effect that only the Secretary of the Department of Public Works and Highways can declare the same a one-way street;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinance, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Arnulfo C. Salazar and Celso P. Porcadilla; be it

RESOLVED, to pass a resolution ENDORSING AS VALID AND MERITORIOUS THE REQUEST OF THE BARANGAY COUNCIL OF DISTRICT XVI, THIS CITY, ON RE-ENACTING A CITY ORDINANCE DECLARING AGUA DULCE STREET A ONE-WAY STREET, HOWEVER, SAID REQUEST BE ENDORSED MEANTIME TO THE SECRETARY OF PUBLIC WORKS AND HIGHWAYS FOR APPROVAL, FOR AGUA DULCE STREET BEING A NATIONAL ROAD, BY LAW, ONLY THE DPWH SECRETARY CAN DECLARE IT A ONE-WAY STREET;

RESOLVED, FURTHER, to earnestly request the Honorable Secretary of DPWH to resolve this issue on probability of making Agua Dulce Street a one-way road with peculiar temper of magnanimity and public-spiritedness, for not only that this request be beneficial to the barangay folks of said District XVI but also to the constituents of Ormoc City;

ENACTED, April 12, 1991.

RESOLVED, FURTHERMORE, to furnish copies of this resolution each to Honorable Jose P. de Jesus, Secretary, Public Works and Highways, Manila; Honorable Carmelo J. Locsin, Congressman, 4th District-Leyte, Ormoc City; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City; the ABC President and the Honorable Punong Barangay - Barangay Council District XVI, Ormoc City;
