RESOLUTION NO. 37

A RESOLUTION TAKING COGNIZANCE OF THE CHANGES MADE BY THE JOINT COMMISSION ON LOCAL GOVERNMENT PERSONNEL ADMINISTRATION IN LINE WITH ITS CIRCULAR NO. 39 S. 1990 ON ABOLISHING TWO EXISTING POSITIONS (PUBLIC SERVICES SUPERVISOR (G-22) AND MARKET SUPERINTENDENT (G-22)) AND CHANGING THE TITLES OF ANOTHER TWO POSITIONS (LIVESTOCK INSPECTOR (G-6) AND LICENSE OFFICER I (G-11)), ALL FOUND IN THE APPROVED PLANTILLA ALLOCATION LIST OF THE CITY GOVERNMENT OF ORMOC, AND FURTHER, TO EARNESTLY REQUEST SAID JOINT COMMISSION TO APPROVE THE UPGRADING/CHANGING OF TITLE OF THE FOLLOWING POSITIONS, A) ZONING OFFICER II (G-16) TO ZONING OFFICER III (G-18), B) SANITATION INSPECTOR III (G-11) TO SANITATION INSPECTOR V (G-15), AND C) MANAGEMENT AND AUDIT ASSISTANT (G-8) TO CLERK IV (G-8).

WHEREAS, the City Administrator has written a letter-indorsement dated 25 March 1991 addressed Her Honor, the City Mayor, the latter having endorsed the same to the Honorable Sangguniang Panlungsod for appropriate action and, a substantial portion of said letter-indorsement is hereunder cited as follows:

"The Joint Commission on Local Government Personnel Administration in its Circular No. 39 dated October 2, 1990, provides changes in the Index Occupational Services, Positions Titles and Salary Grades issued under Circular No. 37.

(RES. NO. 37, S. 1991)

"As a result, the abolition of some classes of positions and the creation of new classes together with an increase or decrease in salary grades provided therein, necessitate a Sanggunian Panlungsod action to implement such changes which affect four (4) positions per approved Plantilla Allocation List (PAL) of the City Government of Ormoc as implemented by Joint Commission Circular Nos. 36 and 37 both dated September 30, 1989, to wit:

A. Abolished Classes

1. Public Services Supervisor, G-22
2. Market Superintendent, G-22

B. Change in Title

3. Livestock Inspector, G-6
4. License Officer I, G-11

New Classes

- Public Services Officer IV, G-22
- Market Supervisor IV G-22
- Livestock Inspector I G-6
- Licensing Officer I, G-11

"Furthermore, we would like to request upgrading/change in title for the following positions:

"All changes resulting from Circular No. 39 shall be included in the original index of Occupational Services, Position Titles and Salary Grades and shall be submitted to the Joint Commission for confirmation."

WHEREAS, as to the significance of a Sangguniang Panlungsod action to implement changes affecting four (4) positions in the approved Plantilla Allocation List of the City, (as results out of the passage of JC Circular No. 39), namely -

A. Abolished Classes

1. Public Services Supervisor, G-22
2. Market Superintendent, G-22

B. Change in Title

3. Livestock Inspector, G-6
4. License Officer I, G-11

New Classes

- Public Services Officer IV, G-22
- Market Supervisor IV G-22
- Livestock Inspector I G-6
- Licensing Officer I, G-11,

it is the modest belief of this august Body on just to take cognizance of the changes made by JCLGPA per its Circular No. 39 s. 1990, and to advise compliance of said circular, for said Joint Commission has the final say on Personnel's Position Titles and Salary Grades;

WHEREAS, tedious and comprehensive deliberations had taken place regarding the upgrading/changing of title of the positions, a) Zoning Officer II (G-16) to Zoning Officer III (G-18), b) Sanitation Inspector III (G-11) to Sanitation Inspector V (G-15), and c) Management and Audit Assistant (G-8) to Clerk IV (G-8), and, ULTIMATELY, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has approved the upgrading of two positions -

- a) Zoning Officer II (G-16) to Zoning Officer III (G-18),
- b) Sanitation Inspector III (G-11) to Sanitation Inspector V (G-15),

and, has approved too the changing of title of one position - Management and Audit Assistant, (G-8) to Clerk IV (G-8);

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., duly seconded by Kagawad Celso P. Porcadilla; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to take cognizance of the changes made by the Joint Commission on Local Government (JCLGPA) in line with its Circular No. 39 s. 1990 on abolishing two existing positions (Public Services Supervisor (G-22) and Market Superintendent (G-22)), thus eligible replacing same with positions - Public Services Officer IV (G-22) and Market Supervisor IV (G-22), respectively, and changing the titles of another two positions (Livestock Inspector (G-6) to Livestock Inspector I (G-6) and License Officer I (G-11) to Licensing Officer I (G-11), all these positions are found in the approved Plantilla Allocation List of the City Government of Ormoc, AND, FURTHER, to earnestly request said Joint Commission to approve the upgrading/changing of title of the following positions, a) Zoning Officer II (G-16) to Zoning Officer III (G-18), b) Sanitation Inspector III (G-11) to Sanitation Inspector V (G-15), and c) Management and Audit Assistant (G-8) to Clerk IV (G-8);
