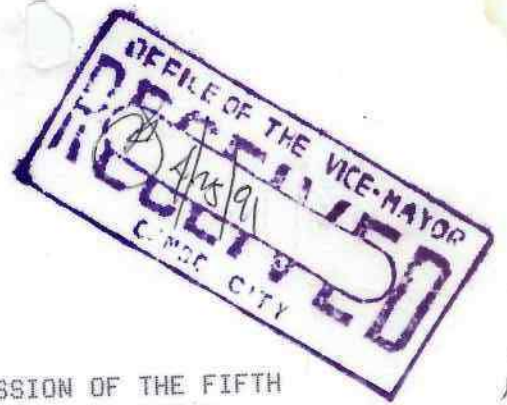

RESOLUTION NO. 39

A RESOLUTION APPROVING RESOLUTION NO. 2 S. 1991 OF THE BARANGAY COUNCIL OF BRGY. MAHAYAG, THIS CITY, EMBODYING ORDINANCE NO. 1, ENTITLED, "ORDINANSA NGA MAGTUGOT SA BARANGAY COUNCIL SA MAHAYAG SA PAGPANGAYO UG BUHIS UG PAGPAHANTANG UG MULTA", HOWEVER, MAKING SLIGHT MODIFICATIONS OF THE PROVISION OF SECTION 1 THEREOF, MAKING THE "MULTA KON MADAKPANG HAYOP NGA MAGSUROY-SUROY SULOD SA BARANGAY PROPER, - KABAW - P50.00, KABAYO - P50.00, UG BABOY - P30.00, MATAG HAYOP.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of Resolution No. 2 s. 1991 embodying Ordinance No. 1 of the Sangguniang Barangay of Mahayag, this city, entitled, "ORDINANSA NGA MAGTUGOT SA BARANGAY COUNCIL SA MAHAYAG SA PAGPANGAYO UG BUHIS UG PAGPAHANTANG UG MULTA";

WHEREAS, this august Body has conformed to the propriety and embodiment of the said Ordinance, the provisions of which, specifically on penalties and fines, are reasonable and within the powers of a Sangguniang Barangay to legislate, however, recommending slight increases of penalties or fines to be imposed on KABAW-P50.00, KABAYO-P50.00, UG BABOY P30.00, matag hayop nga madakpan nga magsuroy-suroy sulod sa Barangay Proper;
