A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 015 S. 1991 OF THE CITY COUNCIL OF DAPITAN, STRONGLY REQUESTING HER EXCELLENCY, PRESIDENT CORAZON C. AQUINO, TO AMEND EXECUTIVE ORDER NO. 273, EXCLUDING NON-FOOD AGRICULTURAL PRODUCT LIKE COPRA FROM THE VALUE ADDED TAX (VAT).

WHEREAS, this august Body is in receipt of Resolution No. 015 s. 1991 of the City Council of Dapitan, entitled "A Resolution strongly requesting Her Excellency, President Corazon C. Aquino, to amend Executive Order No. 273, excluding Non-Food Agricultural Product like Copra from the Value Added Tax (VAT)";
