WHEREAS, the Honorable Sangguniang Fanlungsod is in receipt of a joint letter from Ms. Menita R. Capahi and Mr. Rodolfo A. Torcende, City Budget Officer and DILG-ACGO Officer, respectively, addressed Her Honor, the City Mayor who, in turn, has endorsed the same to this august Body for appropriate action, said letter having requested for legislative authority for the City Treasurer to charge their submitted 1990 vouchers against the current appropriations of their Offices, with the following breakdown:

WHEREAS, the said 1990 vouchers were unpaid as of December 31, 1990 due to constraints imposed at that time on our local support to National Offices;

WHEREAS, the Honorable Acting City Mayor Nepomuceno P. Aparis I, vice Her Honor, the City Mayor, the latter being Out-of-Town on Official Business, has requested in writing to Regional Office, Department of Budget and Management, Tacloban City, for reconsideration of said disallowance, with some portions of said letter-request being hereto cited as follow:

"The agencies affected by subject disallowance are as follow:

"Needless to say, the services contributed by above agencies are vital to our regular operations, hence the city's desire to continue supporting part of their MODE and capital outlay requirements at levels considered reasonable by the city government.

"Further, all subject agencies are housed at local government buildings and facilities; provided with staff support - for drivers, janitorial, security and clerical services, Day Care workers for DSSD - and equipment support (Office Equipment; vehicles) if determined to be necessary to improve their service to the city government. addition, the national officials working with us like City Budget Officer, the DLG Officer, the City Auditor, City and Asst. Health Officers, among Athers, are oftentimes issued travel orders attendant to their functions at our level.

"Justifying our appropriations in support of above offices are the attached certifications relative to their national allocation from their respective agencies.

"In view of above justifications, it is hereby requested that the general disallowance under your review action on our 1990 budgets (annual and supplemental) which are supportive of the MODE and capital outlay requirements of above national agencies be lifted."

WHEREAS, Taxloban DEM Regional Office has replied through their letter dated 01 March 1991 addressed to Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City, having found out the City Government's request for reconsideration to be in order, hence has lifted said disallowance;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, ommittee on Figance, jointly seconded by mga Kagawad Gregorio A. rastorza, Jr. and Nelson DL. Geneston; be it
