RESOLUTION, OMNIBUS IN CHARACTER, NOTING THE CONTENTS OF RESOLUTIONS NOS. 083,084 AND 085, ALL SERIES OF 1991, OF THE SANGGUNIANG PANLUNGSOD NG BAKOLOD, BACOLOD CITY, ENTITLED, A) A RESOLUTION. RESOLUTION REQUESTING THE CONGRESS OF THE PHILIPPINES THRU SENATE PRESIDENT JOVITO SALONGA AND SPEAKER RAMON MITRA TO SPEED UP PASSAGE OF THE PROPUSED BILL GOVERNING THE FORTHCOMING ELECTIONS OF 1992, B) RESOLUTION REQUESTING THE CONGRESS OF THE PHILIPPINES THRU SENATE PRESIDENT JOVITO SALONGA, SPEAKER RAMON MITRA AND THE BICAMERAL CONFERENCE COMMITTEE TO HASTEN THE ENACTMENT OF PROPOSED NEW LOCAL GOVERNMENT CODE, AND C) RESOLUTION REQUESTING THE OFFICE OF THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES AND THE ENERGY REGULATORY BOARD TO IMMEDIATELY CONDUCT A STUDY FOR THE IMMEDIATE REDUCTION OF THE PRICES OF OIL AND OTHER PETROLEUM PRODUCTS IN THE COUNTRY CORRESPONDING TO THE REDUCTION OF MARKETS, INTERNATIONAL FOR THESE PRODUCTS IN THE PRICES RESPECTIVELY.
