RESOLUTION NO. 46

PASSAGE OF AN UPDATED CIVIL SERVICE CODE.

WHEREAS, there are many existing laws on public personnel administration which require integration and updating to reflect current trends and concerns;

WHEREAS, there is a proposed Civil Service Code now pending in the Senate and the House of Representatives that integrates and updates existing laws on public personnel administration;

WHEREAS, there is a dire-need to pass the proposed Code immediately in order to facilitate the delivery of a more efficient and professional personnel service in government;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., jointly seconded by mga Kagawad Sixto T. Pongos and Celso P. Porcadilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request and urge the distinguished Senate and the House of Representatives to facilitate the early passage of an updated Civil Service Code;
