existing laws on public personnel administration;

WHEREAS, there is a dire-need to pass the proposed Code
immediately in order to facilitate the delivery of a more efficient and
professional personnel service in government;

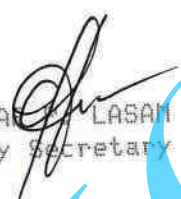
