RESOLUTION NO.

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND BEHALF OF THE CITY GOVERNMENT A DEED OF CONDITIONAL DONATION COVERING A PARCEL OF LAND WHICH IS A PORTION OF A RECLAIMED FORESHORE LAND OWNED BY THE CITY GOVERNMENT OF ORMOC UNDER TAX DECLARATION NO. 32688 CONTAINING AN AREA OF 1,552 SQUARE METERS MORE OR LESS IN FAVOR OF THE DEPARTMENT OF JUSTICE ON WHICH THE PALACE OF JUSTICE WILL BE CONSTRUCTED.

WHEREAS, Her Honor, the City Mayor, in her 1st Indorsement dated 2 May 1991, has informed this august Body about the request of the Department of Justice for a donation of a parcel of land as site of the Palace of Justice which is due for construction; and, in consonance with said request, she requests for authority from the Sangguniang Panlungsod to sign for and in behalf of the City Government, a Deed of Conditional Donation in favor of the Department of Justice, of a land on where the Palace of Justice will be constructed;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Arnulfo C. Salazar and Eufrocino C. Codilla, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to sign, for and in behalf of the City Government, a Deed of Conditional Donation covering a parcel of land which is a portion of a Reclaimed Foreshore Land owned by the City Government of Ormoc under Tax Declaration No. 32688 containing an area of 1,552 square meters, more or less, in favor of the Department of Justice on which the Palace of Justice will be constructed on condition, that in the event said lot is no longer used for the purpose the same together with the improvements will revert back to the City Government of Ormoc;
