RESOLUTION NO. 50

A RESOLUTION REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL
GOVERNMENT, THROUGH THE REGIONAL DIRECTOR, DILG, REGION VIII,
TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC
TO UTILIZE THE AMOUNT OF P40,000.00 FROM OUT OF THE 20%
ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE TO FINANCE TWO
(2) LIVELIHOOD PROJECTS AT BARANGAYS MAHAYAHAY AND QUEZON JR.,
ORMOC CITY.

WHEREAS, this august Body has enacted Resolution No. 86 s. 1990,
approving and adopting Resolution No. 5 s. 1990 of the City Development
Council regarding the Council's adoption of two (2) livelihood projects
at Barangays Mahayahay and Quezon Jr., this city, to be funded from out
of the P40,000.00 Discretionary Fund of BALGU;

WHEREAS, these said livelihood projects pertain to hillside farming
especially goat raising, which, if materialized, would greatly alleviate
the poor living condition of the people in those places;

WHEREAS, it has become a public knowledge that the said P40,000.00
discretionary fund of BALGU has not been released up to now, hence a
many a mga Kagawad, particularly SP Kagawad-Floor Leader Gregorio A.
Yrastorza, Jr., have made representations that these livelihood projects
must instead be funded from out of the 20% Economic Development Fund,
and, the City Budget Officer, too, has recommended that the financial
requirement of P40,000.00 to finance these projects be sourced from the
20% EDF, subject to the approval of DILG regarding utilization of said
amount for the purpose;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng
ORMOC, in SESSION, supportive to the Local Government's program on
rendering continuous services to its constituents, has enacted
Appropriation Ordinance No. 91-15 (Item D) through Resolution No. 49 s.

(RES. NO. 50, S. 1991)

1991 (a copy of same is hereto attached), approving IN PRINCIPLE of an appropriation of P40,000.00 to finance these two (2) livelihood projects at Brgys. Mahayahay and Quezon Jr., this city, from out of the 20% Economic Development Fund, subject, however, to an authorization from the DILG on utilization of said amount;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Edgar Z. Palugod; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to request the Department of Interior and Local Government, through Director Resurreccion S. Salvatierra, Regional Director, DILG, Tacloban City, to authorize the Honorable City Mayor of Ormoc to utilize the amount of P40,000.00 from out of the 20% Economic Development Fund to be made available to finance two (2) livelihood projects at Barangays Mahayahay and Quezon Jr., Ormoc City;

ENACTED, May 9, 1991.

RESOLVED, FURTHERMORE, to furnish copies of this resolution each to Department of Interior and Local Government, through Regional Director Resurreccion S. Salvatierra, DILG, Regional office, Tacloban City; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City, the City Treasurer, the City Budget Officer, the City Auditor, the City Planning and Development Coordinator and the DILG-ACGO Officer, - all in Ormoc City;
