RESOLUTION NO. 51

A RESOLUTION REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT, THROUGH THE REGIONAL DIRECTOR, DILG, TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOC TO UTILIZE THE AMOUNT OF P28,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE FOR THE 1991 OPERATIONAL EXPENSES OF THE CITY DEVELOPMENT COUNCIL (CDC), ORMOC CITY.

WHEREAS, this august Body is in receipt of Resolution No. 2 s. 1991 from the City Development Council, this city, earnestly requesting for an appropriation amounting to P28,000.00 to cover the 1991 Operational Expenses of said Council, with the following breakdown:

1991 Operational Expenses (CDC)

Gasoline and Travel	- P 8,000.00

WHEREAS, the City Budget Officer has recommended, per her 3rd Indorsement dated 6 May 1991, that the financial requirement of the subject appropriation of P28,000.00 for the 1991 Operational expenses of the Ormoc CDC, be sourced from the 20% Economic Development Fund of the General Fund;

WHEREAS, this august Body believes very essential to provide this existing, productive and moving CDC with say "blood for its essential sustenance and growth", hence, has enacted and approved IN PRINCIPLE of an appropriation of P28,000.00 for the Council's 1991 Operational Budget Expenses, subject, however, to an authorization by DILG relative to the utilization of said amount for the intended purpose;



Salvatierra, Regional Director, DILG, Tacloban City, to authorize the Honorable City Mayor of Ormoc to utilize the amount of P28,000.00 from out of the 20% Economic Development Fund to be available for the 1991 Operational Expenses of the City Development Council in Ormoc City;
