RESOLUTION NO. 51

A RESOLUTION REQUESTING THE DEPARTMENT OF INTERIOR AND GOVERNMENT, THROUGH THE REGIONAL DIRECTOR, DILG TACLOBAN CITY, TO AUTHORIZE THE HONORABLE CITY MAYOR OF ORMOO TO UTILIZE THE AMOUNT OF P28,000.00 FROM OUT OF THE 20% ECONOMIC DEVELOPMENT FUND TO BE MADE AVAILABLE FOR THE 1991 OPERATIONAL EXPENSES OF THE CITY DEVELOPMENT COUNCIL CDC), ORMOG CITY.

WHEREAS, this august Body is in receipt of Resolution No. 2 s. 1991 from the City Development Council, this city, earnestly requesting for an appropriation amounting to P28,000.00 to cover the 1991 Operational Expenses of said Council with the following breakdown:

Operational Expenses (CDC)

- P 8.000.00 and Travel 5,000.00 Office Supplies 15,000.00 Meetings Expenses - P 28,000.00 Total
