RESOLUTION NO. 55

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE OVER LOT NO. 2347-B-8-B WITH MR. FIRMO D. GARCIA, REGISTERED OWNER OF SAID LOT CONTAINING AN AREA OF 1,082 SQUARE METERS SITUATED AT BRGY. ALEGRIA, THIS CITY, AT P200.00 PER SQUARE METER, SAID LAND BEING TRAVERSED BY THE CITY DEVELOPMENT ROAD NETWORK, AND, PURSUANT TO RESOLUTION NO. 34 S. 1991 EMBODYING APPROPRIATION ORDINANCE NO. 91-17.

WHEREAS, this August Body has enacted Resolution No. 54 s. 1991 adopting Appropriation Ordinance No. 91-17 (Item A) which has authorized partial payment of P50,000.00 to Mr. Firmo D.
