A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE THE AMOUNT OF P650.00 AGAINST CURRENT APPROPRIATION FOR SPARE PARTS OF THE CITY HEALTH OFFICE, FOR REIMBURSEMENT TO MS. MA. LILY FLORES, PUBLIC HEALTH NURSE - CHO, FOR THE PURCHASE OF SPARE PARTS FOR A MOTORCYCLE BEARING PLATE NO. 3040.

WHEREAS, the City Health Officer has requested in writing Her Honor, the City Mayor, for reimbursement to Ms. Ma. Lily Flores, Public Health Nurse - CHO, for her purchase of spare parts (One (1) set Piston Ring) through OR#160987 in the amount of P650.00 for the needed repair of worn out parts of a Motorcycle bearing Plate No. 3040, with permission and consent given by the City Health Officer;
