A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 50 S. 1991 OF THE SANGGUNIANG PANLALAWIGAN NG BOHOL, TAGBILARAN CITY, SUPPORTING THE PROPOSED DISABLED FILIPINO ACT OF 1991 AND HOUSE BILL NO. 33665 SEEKING TO INCREASE THE MINIMUM WAGE FOR HOUSEHOLD HELPERS AS AUTHORED BY REP. ARTURO A. BORJAL (DISABLED SECTOR).


and House Bill No. 33665 seeking to increase the Minimum Wage for Household Helpers as authored by Rep. Arturo A. Borjal (Disabled Sector);
